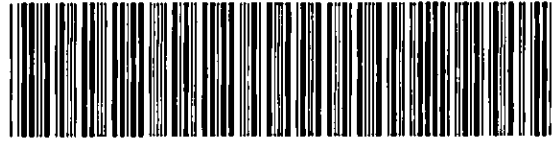

All references to "The Preserve at Laurel Park" are deleted and replaced with "The Preserve at Laurel Lake"; including without limitation, Article VI (Purpose and Powers of the Association) relating to the anticipated Declaration of Restrictions and Maintenance Covenants, and any other such reference contained in the Articles not specifically set forth herein.

THIRD: The amendment was adopted by the Board of Directors on the 30 day of January, 2020.

FOURTH: The amendment was approved by a majority of the members of the corporation on the 30 day of January, 2020.


