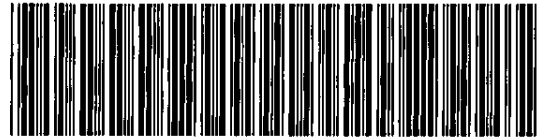

ARTICLES OF INCORPORATION BikeWalk Network

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I Name.

The name of the Corporation is: BikeWalk Network, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The Corporation is organized and shall be operated exclusively for scientific, educational, and charitable purposes, including, for such purposes the following:

To improve the quality of life in the Tallahassee/Leon County region through the promotion of bicycling and walking as an element of the transportation system

ARTICLE IV MANNER OF ELECTION

The Corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the Corporation, provided that the Corporation shall always have at least three directors. ARTICLE X Resignations

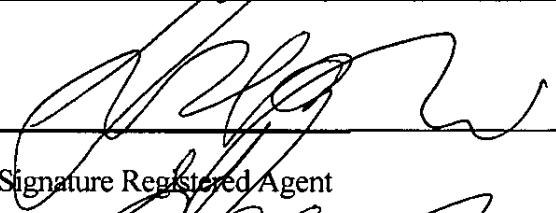
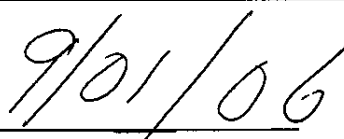
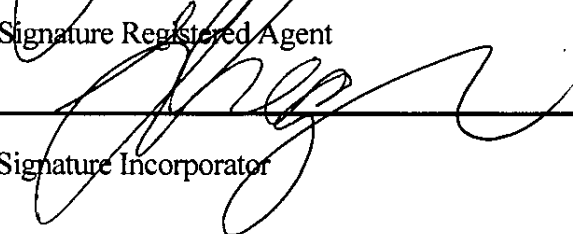
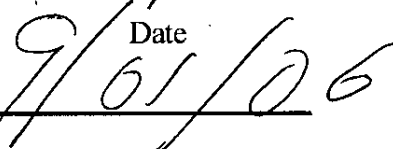
