ARTICLE I Amendments to Articles

- 1. Section 7.2 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:
- Section 7.2 Duration. This corporation shall exist perpetually; provided, however, upon the death of the survivor of GARY R. CHARTRAND, NANCY J. CHARTRAND and their lineal descendants, the corporation shall dissolve.
- 2... Section 9.1 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:
- Section 9.1 Dissolution. Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation by distributing the assets to The Community Foundation, Inc. a Florida not-for-profit organization located in Jacksonville, Florida provided such organization is qualified as an exempt organization under Section 501(c)(3) and which are described in Sections 170(b)(1)(A), 170(c), 2055(a), and 2522(a), and if not, to such organization or organizations which, at such time, is or are qualified as an exempt organization under Section 501(c)(3) and which are described in Sections 170(b)(1)(A), 170(c), 2055(a), and 2522(a), as the board of directors shall determine. All section references are to the Internal Revenue Code of 1986, as amended.
