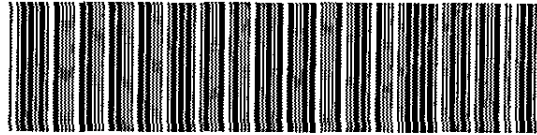

The undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, agrees to the following:

ARTICLE I.

The name of this corporation is:

BREVARD-INDIAN RIVER USBC YOUTH ASSOCIATION, INC.

The principal place of business of this corporation shall be: 6349 Hudson Road, Cocoa, FL 32927 and the mailing address of the corporation shall be the same.

ARTICLE II.



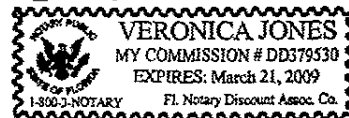
