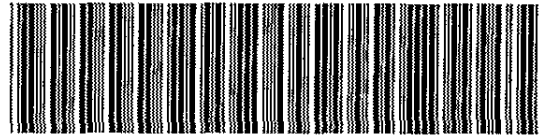

The undersigned, for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, do hereby; adopt the following articles of incorporation:

**ARTICLE I**

NAME

The name of this corporation shall be **EXODUS INTERNATIONAL DELIVERANCE OUTREACH MINISTRIES, INC.** (Hereinafter called the ("Corporation")).

**ARTICLE II**

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the corporation is 650 W. 36<sup>th</sup> Street, Riviera Beach, Florida 33404-2117.

**ARTICLE III**

PURPOSE

The specific purpose of this no-for-profit corporation is for the charitable, religious, and educational training purposes in Section 501 (c) 3 of the International Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so for as is or may be permitted by laws of the State of Florida and Section 501(c) 3 of the Internal Revenue Code 1986 as amended in **EXODUS INTERNATIONAL DELIVERANCE OUTREACH MINISTRIES, INC.** Also there will be several outreach programs organized to operate through **EXODUS INTERNATIONAL DELIVERANCE OUTREACH MINISTRIES, INC.** Women's Retreats, Conferences, Specialized workshops, Seminars, Community Bible Study (CBS), Personal Development Programs (P.D.P.), Prayer Outreach Program (POP), Women Health Outreach Program (WHOP), Pastor and Wives Enrichment Program (PAWEP), Girls 2 Girls Mentoring Program (G2GMP), Boys 2 Boys Mentoring Program (B2BMP), Corporate Intercessory Prayer Program (CIPP), etc.

**ARTICLE VI**  
**BOARD OF DIRECTORS**

A board of directors consisting of no less than five (5) directors shall manage the affairs of this corporation. **ARTICLE VIII**  
**DISSOLUTION**

Upon the dissolution or winding up of the corporation, its assets remaining after payment or provisions for payment of all debts and liabilities of the corporation shall be distributed to a Not-For-Profit fund, foundation or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (C) 3 of the Internal Revenue Code 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

**ARTICLE IX**  
**LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its Directors, Officers, Members, or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions on furtherance of any of its purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501(C) 3 of the Internal Revenue Code 1986, as amended). And the corporation shall not participate or intervene in (including the publishing or distributions of statement), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (C) 3 of the Internal Revenue Code 1986, as amended (or the
