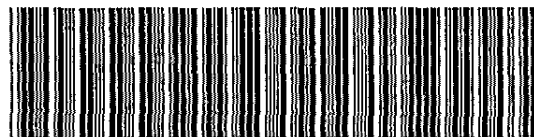

**ARTICLE I  
NAME**

The name of the corporation shall be Off-Leash Dog Beach Of Hollywood Association, Inc.

**ARTICLE II  
PRINCIPAL OFFICE**

**ARTICLE III  
PURPOSE**

A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Corporation Law for public and charitable purposes only.

B. The specific purpose of this corporation is to raise funds needed to establish, maintain and enhance the Off-leash Dog Beach of Hollywood, in which pet dogs can exercise without leash restraint in a clean, healthy and safe environment; and to provide charitable contributions for the care and humane treatment of animals.

C. To receive, invest and use funds acquired through dues, fundraising events, donations, grants, gifts, bequests, and solicitations for the purposes which this corporation was formed.

**DISSOLUTION**

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the income or assets of this corporation shall ever benefit any director, officer, member or private person thereof. Upon the dissolution of the corporation, any assets remaining after payment or provision for payment of all debts and liabilities of this corporation, shall be distributed to nonprofit funds, foundations or corporations organized and operated exclusively for similar charitable purposes, and which has established tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

**ARTICLE IV**  
**MANNER OF ELECTION**

A. The initial directors and/or officers will be appointed by the incorporator, and serve until the first annual meeting of members and until their successors are elected and qualified.

B. The manner of election and qualification of members, directors and/or officers shall be as set forth in the by-laws of the corporation.

**POWERS**

A. This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.

B. This corporation shall have all the powers specified in the Florida Nonprofit Public Benefit Corporation Law, subject only to the limitations imposed by these Articles of Incorporation and applicable public law.

C. No part of the activities of this corporation shall attempt to influence legislation nor participate or intervene in any political campaign (including the publishing or distribution of materials) on behalf of any candidate for public office.

**DIRECTORS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of directors. The number of directors of this corporation shall be fixed from time to time by the Bylaws of this corporation.

**MEMBERS**

The qualification of members of this corporation, the different classes of members (if any), the property, voting rights, and other privileges of membership shall be prescribed from time to time in the Bylaws of this corporation.
