ARTICLE I NAME

The name of the corporation shall be:

TLC Rabbit Rescue, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

1342 Tung Hill Drive, Suite C, Tallahassee, Florida 32317

ARTICLE III: PURPOSES:

This corporation is organized exclusively for charitable, educational and scientific purposes. The purposes of this corporation include the rescuing of rescue rabbits no longer wanted by their owners; the funding of medical treatment for seriously ill rabbits that otherwise would be euthanized by shelters; and the providing of public education regarding the proper care of rabbits. Nothing in this paragraph shall allow this organization to carry on any activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV: DISSOLUTION:

Upon dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations as such Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Directors shall be elected annually by a majority of the membership.

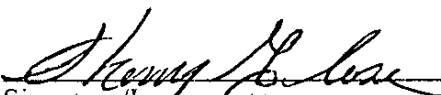
