The undersigned incorporator to these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I. NAME OF CORPORATION

The name of the corporation is: SUWANNEE HIGH SCHOOL GOLF BOOSTERS, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business of this corporation shall be:

105 N. Ohio Avenue Live Oak, Florida 32064

ARTICLE III. PURPOSE

This corporation is organized for the following purposes:

- A. To support and promote a successful golf program at Suwannee High School;
- B. To financially assist the program for golf for the benefit of the students who participate on the team;
- C. To sponsor fund-raising projects and activities in order to raise the funds to carry out its purpose; and
- D. To encourage, publicize and support the organized golf program at Suwannee High School.

ARTICLE IV. NOT FOR PROFIT NATURE; POWERS

- The Corporation is organized pursuant to the Florida Nonprofit
 Corporation Code and is a nonprofit corporation as described in Section 501(c)(3) of
 the Internal Revenue Code, as amended.
- 2. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislations, and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.
- 3. Anything contained in these Articles of Incorporation to the contrary notwithstanding, the Corporation shall not carry on or otherwise engage in any activities not permitted to be carried on or engaged by (i) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as amended, or any corresponding section of any future tax code; (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, as amended, or any corresponding section of any future tax code; or (iii) a corporation organized and existing under the Florida Nonprofit Corporation Code.
- 4. In the event of the dissolution and liquidation of this Corporation, to the extent allowed or permitted under applicable laws, the property and assets of the

Corporation shall be as determined by the Board of Directors, distributed to or sold and the proceeds of such sales distributed to (i) the Florida Baptist Convention, or (ii) any other organization(s) organized and operating for the same purposes for which the Corporation is organized and operating or any organization(s), foundation(s), fund(s), or corporation(s) organized and operating exclusively for religious, charitable, scientific, or educational, or other purposes permitted by Section 501(c)(3) of the Internal Revenue Code, as amended, all of which such organizations, foundations, funds, or corporations shall be exempt under Section 501(c)(3) of the Internal Revenue Code, as amended. In the event that any assets are not disposed of in accordance with the provisions of these Articles of Incorporation or that the Corporation shall fail to act within a reasonable time in the manner provided in these Articles of Incorporation, the Court of Bradford County shall, upon application of one or more persons having a real interest in the Corporation or its assets make such distribution(s) as provided in these Articles of Incorporation.

ARTICLE V. INITIAL DIRECTORS/OFFICERS

This corporation shall have nine (9) directors initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of the corporation in the manner provided by law, but shall never be less than three (3). The method of election of directors is as stated in the bylaws.
