

Article IX Term And Dissolution

Article XI Non Profit Organization

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, or other private persons, except that the coorporation shall be authorized and empowered to pay reasonale compensation for services rendered and to make payments and distributions in furtherance of the purposes set for article X.
