

A Nonprofit Corporation

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

**ARTICLE I
NAME**

The name of this corporation shall be:

Youth With Vision, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

The principle place of business and mailing address of this corporation shall be:

356 Yorktowne Drive, Daytona Beach, FL 32119

**ARTICLE III
PURPOSE**

The general purpose for which the corporation is organized is: This corporation is organized exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

This corporation is organized to engage in any lawful activity for which corporations may be organized under General Corporation Law of Florida, provided, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(x)(3) tax-exempt purposes, which are described in other provisions of these articles.

This corporation is organized to provide educational opportunities to encourage, mentor and empower youth to develop vision for their lives; be empowered with skills and information to move forward toward that vision, and in the process of doing so, learn how to love and respect themselves.

**ARTICLE IV
MANNER OF ELECTION**

The manner in which directors are elected or appointed:

The initial directors are appointed by the Incorporator. Subsequent directors will be elected by a majority of board members in office. The total number of directors will be six. Potential directors will be determined by professional qualifications. Directors will be of minimum age. Board terms will be determined by the corporation's by-laws.

**ARTICLE VIII
ADDITIONAL PROVISIONS**

The property of this corporation is irrevocably dedicated to charitable and educational purposes. Upon dissolution and winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions which are deductible under Section 170 ©(2) of the Internal Revenue Code.


