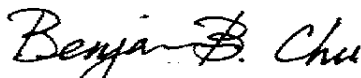

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, Florida Statutes, (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Abundant Grace Covenant Church, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 175 SW 166th Avenue, Pembroke Pines, Florida 33027.

ARTICLE III PURPOSE

We accept the Bible, the canonized Old and New Testaments, as the written Word of God. We believe the Bible is the only essential and infallible inspired truth that will lead us to salvation through faith in Jesus Christ. Further more every doctrinal format, whether of creed, confession, or theology must be put to the test of the full counsel of God in Holy Scripture.

We believe there is only one God, who is infinite, eternal, almighty, holy, and perfect in truth, and love. In the unity of the godhead there are three persons, the Father, the Son and the Holy Spirit, who are co-existent, co-equal, and co-eternal.

We believe God the Father is the Creator of heaven and earth. By His Word and for His glory, God freely and supernaturally created the world out of nothing. Through the same Word He daily sustains all his creatures.

ARTICLE VI NOT FOR PROFIT ORGANIZATION

Said corporation is organized exclusively for religious purpose, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII DISPOSITION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
