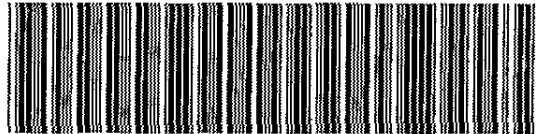

The undersigned, being qualified to act as an incorporator under Florida Statutes Chapter 617 (corporations not for profit), adopts the following articles of incorporation for the purposes of organizing a corporation not for profit.

1. The name of the corporation is:

ZEPHYRHILLS/WESLEY CHAPEL MINISTERIAL ASSOCIATION,
INC.

2. The purposes for which the Corporation is organized are:

To promote unity of spirit and work among the Churches of Zephyrhills/Wesley Chapel and their surrounding areas in the growth of religious and moral welfare of these communities.

To carry on any other charitable activity which the association shall determine advisable, whether alone or in conjunction with any other organization.

Notwithstanding any other provision of these articles, the corporation shall not carry on activities that are prohibited for corporations exempt from Federal Income Tax under Section 501(c)3 of the Internal Revenue Code of 1986 (or in the corresponding provision of any future United States Internal Revenue Code or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or in the corresponding provision of any future United States Internal Revenue Code.

3. The duration of the Corporation is perpetual, but if the corporation shall dissolve, its assets remaining after payment of all costs and expenses of such dissolution, shall be distributed to organizations which have qualified for exemption under Section 501(c)3 of the Internal Revenue

Code of the 1986 (or in the corresponding provision of any future United States Internal Revenue Code), or the federal, state or local Government for public purposes only. None of the assets of the Corporation shall be distributed to any member, director, or officer of the Corporation..

4. All present members of the Zephyrhills/Wesley Chapel Ministerial Association, Inc. an unincorporated organization, are automatically members of the corporation. Henceforth, the qualifications of members and the manner of their admission shall be as regulated by the by-laws.

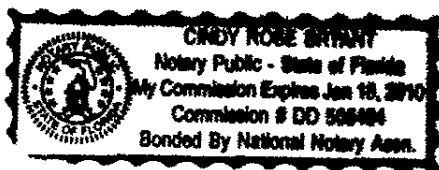
