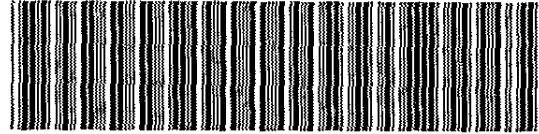

ARTICLE I NAME

The name of the corporation is "The Lake Helen Garden Club, Inc."

ARTICLE II PRINCIPAL OFFICE

The Lake Helen Garden Club, Inc. is located in the City of Lake Helen located in Volusia County, Florida 164 Cook St., Lake Helen, Fl. 32744

ARTICLE III PURPOSE

The purpose of this organization is to bring together individuals interested in the preservation of the natural environment; growth and development of plant life and increase our knowledge of horticultural. Formed in 1936 the Garden Club raised funds and in 1942 purchased a piece of property and named it Asa Gray Park (identified by Volusia County Appraisers Office as Parcel ID 30-17-31-01-10-0010). The Garden Club is responsible for the protection and maintenance of this property for use as a passive park for the residents of the City of Lake Helen and to retain ownership of said park in perpetuity.

This is a not-for-profit, benevolent, non-political and non-sectarian organization.

ARTICLE IV MANNER OF ELECTION

Officers shall be elected annually at the April meeting by ballot. The officers will be residents of Lake Helen and shall be President, Vice President, Recording Secretary and Treasurer. The executive board shall consist of the officers above named.
