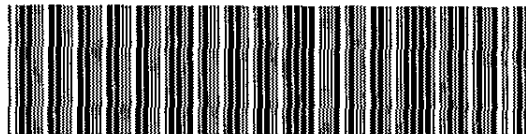

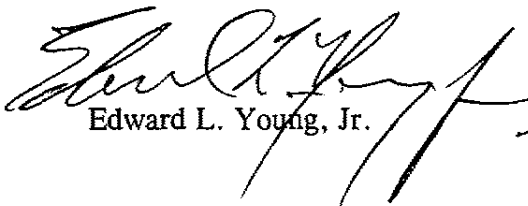

**ARTICLE I - NAME**

The name of this Corporation is: Onething Prayer & Worship Center, Inc.

**ARTICLE II - DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE III - PURPOSE**

The Corporation is formed as a church exclusively for religious, charitable, and educational purposes, within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

The Corporation shall not engage in any action prohibited by the Florida Not for Profit Corporation Act or by the Internal Revenue Code and no part of the net earnings shall inure to the benefit of, or be distributed to, its members, directors or officers. However, the Corporation may pay reasonable compensation to any member, director, or officer for reasonable services.

**ARTICLE IV - NON-STOCK BASIS**

The Corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock. The Corporation may issue membership certificates as provided in the corporate bylaws.
