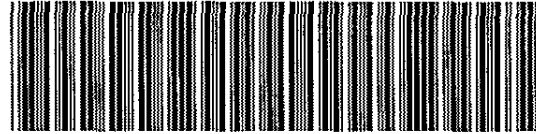

ONE: The name and address of this principal corporation is FRESH MASTERS, INC. at 13280 SW 120th Street, Miami, Florida 33186 in Miami-Dade County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

TWO: The purpose or purposes for which the corporation is formed are as follows: to dance instruction and entertainment for those in low-income communities. The programs will consist of: Dance Instruction, Seminars/Workshops, Physical Fitness Instruction, Mentoring, Job Placement, Drug and Violence Intervention, Counseling, Nutritional Counseling, and referrals to other programs to aid those in need.

THREE: The duration of this Corporation shall be perpetual, with no stock and shall have no members.

FOUR: The address of the registered office is 15665 Miami Lakes Way, #208a, Miami Lakes, FL 33014, and the name of the Registered Agent of the Corporation shall be:

FIVE: (1) This Corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

(2) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

SIX: The Directors are elected in accordance with the By-laws. The name and address of the persons appointed to act as the initial Directors of this Corporation are:

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
