## ARTICLES OF INCORPORATION OF HAND OF LOVE OUTREACH, INC.

#### ARTICLE I:

The name of the corporation is Hand of Love Outreach, Inc.



#### ARTICLE II:

The address for the initial registered office is 300 Bobwhite Drive, Pensacola, Florida 32514. The corporation is organized pursuant to the State of Florida Nonprofit Corporation Code.

#### ARTICLE III:

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantage individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to (1) To provide faith based and non-profit organization referrals and outreach programs, job training, job placement, land acquisition, housing, temporary shelter, substance abuse awareness and prevention, family abuse awareness, tutoring, health, counseling and other programs, to aid those in need.

#### ARTICLE IV:

The directors are elected in accordance with the bylaws. A Director must be at least 18 years of age. The number of directors shall be three (3).

#### ARTICLE V:

The duration of this corporation shall be perpetual, no stock and shall have no members.

#### ARTICLE VI

- (A) This corporation is organized and operates exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code.

#### ARTICLE VII

The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shave ever inure to the benefit of any director, officer or member thereof of the benefit of any private person.

#### ARTICLE VIII

On the dissolution or winding up of the corporation, its assets remain after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation, which is organized and operated for educational and charitable under Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to a federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
