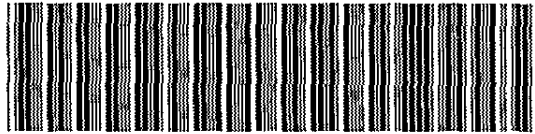

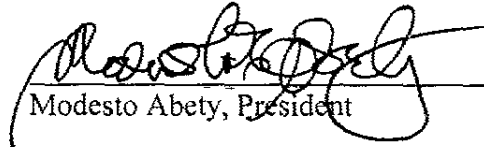
The Articles of Incorporation of FLORIDA CHILDREN'S COUNCIL, INC., a Florida not for profit corporation (the "Corporation"), are hereby amended as follows:

Article I of the Articles of Incorporation of the Corporation is hereby amended so as to read in its entirety as follows:

ARTICLE I: The name of the corporation shall be Florida Children's Services Council, Inc. (the "Corporation").

There are no members of the Corporation or members entitled to vote on this Amendment. This Amendment was unanimously approved on the 20th day of October, 2006, by the Board of Directors of the Corporation pursuant to Section 617.1002, Florida Statutes, such vote being sufficient for approval.
