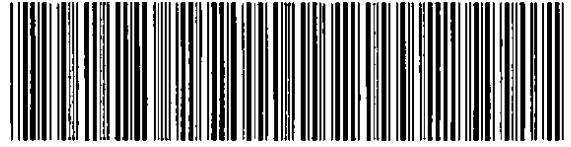

TO ARTICLES OF INCORPORATION OF
FLORIDA CHILDREN'S SERVICES COUNCIL, INC.**


The Articles of Incorporation of FLORIDA CHILDREN'S SERVICES COUNCIL, INC., a Florida not-for-profit corporation (the "Corporation"), are hereby amended as follows:

Article I of the Articles of Incorporation of the Corporation is hereby amended so as to read in its entirety as follows:

ARTICLE I: The name of the corporation shall be Florida Alliance of Children's Councils & Trusts, Inc. (the "Corporation").

There are no members of the Corporation or members entitled to vote on this Amendment. This Amendment was unanimously approved on the 7th day of January, 2022, by a vote of the Board of Directors of the Corporation, such vote being sufficient for approval pursuant to section 617.1002, Florida Statutes (2021).
