#### ARTICLES OF INCORPORATION

### ARTICLE VIII TAX EXEMPTION REQUIREMENTS

This corporation is organized and operated exclusively for the religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE IX DISTRIBUTION UPON DISSOLUTION
