**ARTICLE I NAME**

The name of the corporation shall be:

Iglesia del Dios Viviente Inc.

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Iglesia del Dios Viviente is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the state of Florida, as a Nonprofit religious Corporation exclusively for religious purposes. The specific purposes for which this corporation is organized are religious ones, to wit: To create, establish, and operate an Pentecostal Evangelical Church, to proclaim Christ, to bring people to know Him, to take Christ to the world, to provide a place for public worship, religious training and education where this can occur, and to otherwise encourage and aid the growth, nurture, and spread of the gospel, and to render Christian service, both material and spiritual to the sick, the aged, the homeless and the needy, as the Lord directs. In carrying out such purposes, its congregations, institutions, agencies, and members, to contribute or otherwise assist these and other corporations, organizations, and institutions carrying on such activities which are consistent with the purposes of this corporation, and to take such other actions assisting the work of Iglesia del Dios Viviente Inc. as are consistent with these purposes. To acquire by purchase or gift, such property whether real or personal to facilitate the foregoing purposes, and to have and exercise all other powers, rights and privileges granted by the state of Florida. The recital of these purposes as contained in this paragraph is intended to be exclusive of any and all other purposes, this corporation being formed for such religious purposes and community services only.

## **ARTICLES OF INCORPORATION**

### **ARTICLE VIII TAX EXEMPTION REQUIREMENTS**

This corporation is organized and operated exclusively for the religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements on behalf of any candidate for public office).

### **ARTICLE IX DISTRIBUTION UPON DISSOLUTION**

The property of this Corporation is irrevocably dedicated to religious purposes meeting the requirements of Section 501 (c)(3) of the Internal Revenue Code, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, trustee, officer or member of this corporation, or to the benefit of any individual.

Upon the winding up and dissolution of this Corporation, and after paying and adequately providing for all debts and liabilities of the Corporation, the assets of this corporation shall be distributed to a fund, foundation or organization organized and operated exclusively for the purposes specified in 501 (c)(3) of the Internal Revenue Code.
