Purpose:** This corporation is established to include representatives from Emergency Medical Services and hospitals in West Central Florida to advise the regional communities to properly identify, transport to appropriate facilities and treat acute stroke patients as quickly as possible (per Florida Stroke Law criteria). Through research we hope to gather information from the regional communities to encourage entire system change to optimize care and standardize protocols.

If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax-exempt organization.

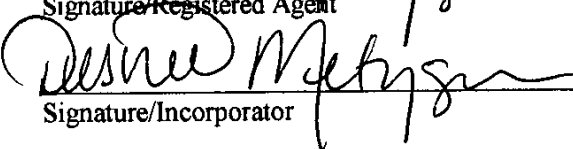
