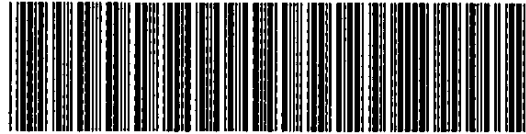

**ARTICLES OF INCORPORATION**  
**FOR**  
**VICTORY IS YOURS INCORPORATED**

We, the undersigned, with other persons being desirous of forming a corporation exclusively for charitable purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I**  
**NAME**

The name of this corporation is Victory is Yours Incorporated and its place of business is 335 Griffin Avenue, Lakeland, Florida 33801

**ARTICLE II**  
**PURPOSE**

The purpose for which the corporation is organized is exclusively charitable, and educational within the meaning of Section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law; to prevent recidivism by encouraging non-chemical dependent lifestyles, which include devotion to family, work ethics, and self respect.

**ARTICLE III**  
**MEMBERSHIP**

The qualifications of members and the manner of their admission shall be by invitation to those who have a heart for this ministry and are desirous of helping the female ex-offender in accordance with our purpose.

**ARTICLE IV**  
**EXISTENCE**

The corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.

**ARTICLE V**  
**REGISTERED OFFICE AND REGISTERED AGENT**

The name of the initial Registered Agent of this Corporation and the street address of the initial Registered office are as follows:

**ARTICLE VI**  
**AMENDMENTS AND BY LAWS**

This corporation shall not carry on propaganda, or otherwise act to influence legislation or participate in political campaigns as a substantial part of its activities. No part of the income of the corporation shall be paid or inure to the benefit of any person within the corporation. Any amendments to the Bylaws shall be by majority vote of the Board of Directors after due notice of the meeting for amendment, as recorded in the Minutes of the Board.

**ARTICLE VII**  
**INITIAL BOARD OF DIRECTORS**

This corporation shall have three (3) directors initially. The number of directors may be either increased or decreased from time to time as provided in the bylaws, but shall never have less than three (3). The name and address of the initial directors of this corporation is as follows:

**ARTICLE VII**  
**NON-PROFIT**

The corporation shall be authorized to pay reasonable compensation for services rendered and may confer benefits upon its members in conformity with its purposes. The corporation shall operate according to the IRS section 501c3 as a nonprofit corporation.

**ARTICLE XI**  
**TAX EXEMPT STATUS**

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income

tax under IRS section 501(c)3 (or the corresponding provisions of any future United States Internal Revenue Code or the corresponding provision of any future internal revenue law).

**ARTICLE X**  
**DISTRIBUTION OF ASSETS**

Upon dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of IRC section 501(c)3 or corresponding sections of any future federal tax code, or to the federal government, or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE XI**

**ARTICLE XII**  
**INDEMNIFICATION**

The corporation shall indemnify any person who was or is a party, or is threatened to be made a party, to any threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative, to the full extent permitted by Chapter 607.0850 of the Florida Statutes, or any successor thereto.

**ARTICLE XIII**  
**LONG TERM EMPLOYMENT CONTRACT**

The Board of Directors may authorize the corporation to enter into employment contracts with any executive officer for periods longer than one year, and any charter of bylaw provision for annual election shall be without prejudice to the contract rights if any, of the executive officer under the contract.

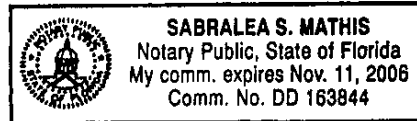
