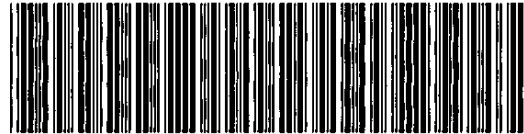

**ARTICLES OF INCORPORATION
OF
VISITING NURSES OF SOUTHWEST FLORIDA, INC.**

These Articles of Incorporation are signed and acknowledged by the incorporator for the purpose of forming a not-for-profit corporation under the provision of Chapter 617 of the Florida Statutes known as the Florida Not For Profit Corporation Act, as follows:

ARTICLE I

The name of the corporation is Visiting Nurses of Southwest Florida, Inc.

ARTICLE II

The term of this corporation is fixed in perpetuity and is to commence when these Articles of Incorporation are filed with the Department of State.

ARTICLE III

Visiting Nurses of Southwest Florida, Inc. is organized to promote skilled nursing care and other therapeutic services to individuals and families, and in general, to exercise any, all and every power for which a non-profit organization organized under the Florida Not For Profit Corporation Act can be authorized to exercise. All of the property of this corporation and any accumulations thereof shall be held and administered to effectuate these purposes. In no event shall its property, whether principal or income, be diverted to private purposes.

ARTICLE IV

The initial registered office is located at 3653 Central Avenue, Fort Myers, Florida 33901, and Anna L. Vann of 3653 Central Avenue, Fort Myers, Florida 33901 is the initial registered agent.

ARTICLE V

The number of directors constituting the initial board of directors is four (4), and such board shall be known as Trustees. The names and addresses of the initial board of Trustees are:

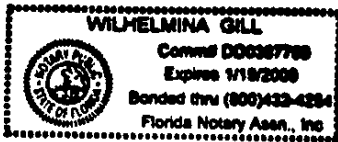
