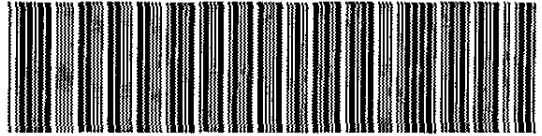



ARTICLE VIII. MEMBERSHIP.

This corporation is a membership driven entity.

ARTICLE IV. PROHIBITED ACTIVITIES

(a) No part of the earnings of On The Right Track Child Development Center Inc., shall inure to the benefit of/ or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these article of incorporation. No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the publishing or distribution of statements) and any political campaign on behalf of or in opposition to any other activities not permitted to be carried on (a) by a Charitable, Religious and Educational not for profit corporation exempt from federal income tax under Section 501 (c) (3) of the Code or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Code.

(b) Distribution Upon Dissolution

Upon the dissolution of On The Right Track Child Development Center, Inc., can only be done by the express will of the Executive Board, decree of Court, or bankruptcy. In such a case, all efforts shall be terminated and all assets shall be liquidated in order to satisfy creditors. All remaining assets will be liquidated in order to satisfy creditors. All remaining assets will be donated to other not for profit corporations by the Superior Court of the Commonwealth in which this Corporation shall reside.
