# ARTICLES OF INCOPORATION OF THE GARDENS AT TEMPLE TERRACE CONDOMINIUM ASSOCIATION, INC. A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt the following articles of incorporation.

#### ARTICLE I: NAME

The name of this corporation is THE GARDENS AT TEMPLE TERRACE CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "association," these articles of incorporation as the "articles," and the bylaws of the association as the "bylaws."

#### ARTICLE IL PURPOSE

This association is organized for the purpose of providing an entity under the Florida Condominium Act ("the Act") for the operation of a condominium located in Hillsborough County, Florida and known as: This Gardens at Temple Terrace Condominium, created under the declaration of condominium ("the declaration").
