Articles of Incorporation of 1st Coast Families Foundation, Inc. a Florida not for profit corporation

We, the undersigned, with other persons being desirous of forming a corporation for charitable purposes under the provisions of Chapter 617 of the Florida Statutes do agree to the following:

Article I Name

The name of the corporation shall be 1st Coast Families Foundation, Inc., a not for profit corporation.

Article II Term of Existence

This corporation is to exist perpetually.

Article III Commencement of Existence

The corporation shall be deemed to commence its existence on the date of the filing and assignment of chapter number.

Article IV Principal Place of Business

The principal place of business and mailing address of this corporation shall be:

1st Coast Families Foundation, Inc.

3992 Reds Gait lane

Jacksonville, Florida 32223

Article V Purposes

The purpose for which this organization is organized is to strengthen families within the greater Jacksonville community through support and assistance to families in need due to emergency circumstances or other causes. The Corporation will work with other charitable organizations, when appropriate, to assist local families. Assistance may be provided in the form of cash disbursements for specific purposes, shelter and subsistence when necessary, and any other form which will serve to support the family in its time of need. Assistance may also be provided to prevent an individual or family from suffering hardships which could negatively affect a family.

Funds for establishing the foundation will be derived from initial contributions from Weichert Realtors, 1st Coast. Operating funds for providing support and assistance to First Coast families will come from Weichert Realtors, 1st Coast sales transactions and other contributions received from Weichert Realtors, 1st Coast customers and associates. The Corporation may also solicit funds from members of the general public and other charitable foundations, associations, and governmental entities.

Board of Directors
