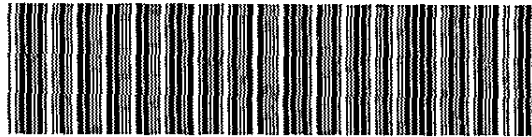

ARTICLE I: NAME

The name of the corporation shall be:

The purpose for which the corporation is organized is:
