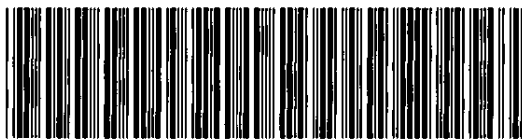

The undersigned do hereby make, subscribe, acknowledge and file with the Secretary of State these Articles of Amendment in accordance with the unanimous vote of the entire voting interests of the association, which amount is sufficient for approval, at a duly called meeting of the members on November 1, 2006, after unanimous adoption of a Resolution proposing said amendments by the Board of Administration. Article IV and Article V of the Articles of Incorporation of Cypress Walk Townhome Condominium Association, Inc. are, and shall hereby be, amended to read as follows:

**ARTICLE IV - TERM OF EXISTENCE**

**The Association shall have perpetual existence. If the Association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that is not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.**
