

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: Comunidad Cristiana de Orlando, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of allowing a group of Reformed Church of America believers with the same ethnic and cultural background to join together as a church to seek the lost souls for Jesus Christ and who are also willing to be conformed with the law of the State of Florida.

ARTICLE IV - COMPONENT

The corporation shall be a constituent of the Reformed Church in America, and shall be located in Orlando, Florida. The corporation shall be formed, maintained, and operated for religious purposes as provided in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future Internal Revenue Code. Also, all assets of the corporation shall be dedicated to the exempt poses in these Articles of Incorporation.

ARTICLE IV - BOARD OF DIRECTORS (BOARD OF TRUSTEES)

Section 1. Be it enacted by the General Assembly of the State of Florida, that Pastor Fernando Jensen, and Jose Gaztambide, Luciano Rivera, Voltaire Nunez, and Luis Lino, Trustees of the Comunidad Cristiana de Orlando, Indc., and their successors as such, be and they are hereby created the body of politic and corporate, by the name and style of the Trustees of the Comunidad Cristiana de Orlando, Inc. and by that name shall have the perpetual succession and a common seal, and may sue or be sued, plead or be pleaded in any court of law or equity in this state.

Section 2. That when any vacancy in said Board may occur by death, resignation, or otherwise, or other disqualification to act, to be judged of by the church at a regular business meeting, it shall be competent for the member of such church

to fill such vacancy or vacancies at any regular business meeting. Said church shall, also, have power to remove from office any one or more of said trustees, a majority of all the members present at a regular business meeting concurred therein, and may proceed to fill such vacancy in the manner provided appointment of a trustee shall take place until notice of such intention has been given at a previous regular business meeting of the church. The manner of election of the Directors shall be as provided in the by-laws of the corporation.

Section 3. That the above named trustees, and their successors, are hereby invested with full power, to be selected by the church in Orlando to purchase and receive title of any property, and any property of the Comunidad Cristiana de Orlando may be used exclusively and in the benefit of the church (should there ever be a schism) as adhere, to the articles of faith as now held by the church, forever.

Section 4. That said trustees, or their successors, shall have and they are hereby vested with power to sell and convey any title they may hold, or may hereafter hold, in trust for said church, or may make such other disposition of the same as said church may order. Notice have been given at a previous meeting of such intended sale or disposition, and not otherwise; and to do and perform all acts common to limited corporations not to conflict with the laws of this state.

ARTICLE V - PRINCIPAL OFFICE AND MAILING ADDRESS
