ARTICLE I.

The name of the corporation shall be COMPASSIONATE HEARTS MINISTRIES, INC.

ARTICLE II.

The principal place of business and the mailing address is 1269 Linden Way, Deland, Fl. 32724.

ARTICLE III

The purpose for which the corporation is formed is:

- A. To administer the gospel of our Lord, Jesus Christ, to the entire world through direct and indirect ministry.
