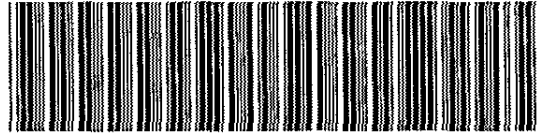

### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

### ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The board of directors where elected by the regular members following a democratic procedure using ballots for a period of two year. All the agreed not to use the net earnings of the corporation for personal purpose or to other members, only they are authorized to receive reasonable pay for services rendered. Not to use a substantial amount of money on propaganda (ads). The corporation shall not participate or intervene on political campaign. As non profit corporation shall carry only activities permitted or authorized by the Internal Revenue Service under section code, 501 (c) (3) or the corresponding section of any future federal tax code. Nevertheless, "notwithstanding any other provision of these articles, this corporation at all not, accept to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation"

Upon the dissolution of the corporation, assets shall be distributed for a similar Panamanian non profit corporation in the State of Florida or other exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Service code, or the corresponding section of any future federal tax code, or shall be distributed to the local, State or federal for a public purpose. The assets should be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes of the organization or organizations, the court shall determine, which are organized and operated exclusively for such purposes.
