ARTICLES OF INCORPORATION OF THE WORLD JUNIOR GOLF FOUNDATION, INC.

The undersigned, for the purpose of forming a corporation not-for-profit under the laws of the State of Florida, Chapter 617, the Florida Not-For-Profit Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I Name

Section 1.1 - Name. The name of this corporation shall be THE WORLD JUNIOR GOLF FOUNDATION, INC.

ARTICLE II Principal Office and Mailing Address

Section 2.1 - Principal Office and Mailing Address. The principal place of business of this corporation shall be 104 Pitts Still Road, Ponte Vedra Beach, Florida 32082, and the mailing address of this corporation shall be 104 Pitts Still Road, Ponte Vedra Beach, Florida 32082.

ARTICLE III Purposes

<u>Section 3.1 - Purposes.</u> This corporation is organized exclusively for charitable, educational, religious and scientific purposes. It is intended that this corporation shall not engage in any activity for pecuniary profit.

Section 3.2 - Limitations on Actions. All of the assets and earnings shall be used exclusively for the purposes set forth herein, and no part of the net earnings of the corporation shall enure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the corporation shall be the carrying-on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE IV Directors

Section 4.1 - Number. This corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time, but shall never be less than the number required by F. S. Section 617.0803(1) or successor provision.

Section 9.1 - Dissolution. <u>Section 10.1 - Bylaws.</u> The initial bylaws of this corporation shall be adopted by the directors. Bylaws shall be adopted, altered, amended or repealed from time to time by the board of directors.

ARTICLE XI Amendment

<u>Section 11.1 - Amendment.</u> This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation.
