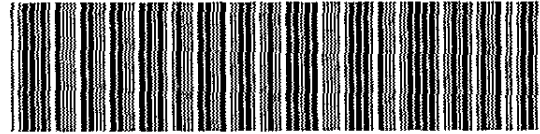

The undersigned citizen of the United States, desiring to form a not for profit corporation under the Florida Not For Profit Corporation Act, Chapter 617, of the Florida Statutes, certify and acknowledge the following:

ARTICLE I

The name of the Corporation Not for Profit shall be:




