ARTICLES OF INCORPORATION OF C.T.S.C., INC.

The undersigned incorporator, a natural person competent to contract, hereby files these LORIDA Articles of Incorporation in order to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I NAME AND ADDRESS OF THE CORPORATION

The name of the corporation shall be C.T.S.C., INC. (hereinafter the "Corporation"). The principal office and mailing address of the Corporation shall be 1528 Sixth Street, West Palm Beach, Florida 33401.

ARTICLE II PURPOSES

The purposes for which this Corporation is organized are exclusively charitable, scientific and educational within the meaning of Section 501(c) (3) of the Internal-Revenue Code of 1986, or corresponding provisions of any future United States Internal Revenue Law, including, but not limited to, serving the needs and provide services, including facilities and personnel for the care, treatment and rehabilitation of persons in need.

ARTICLE III PROHIBITED ACTIVITIES

No dividend shall be paid, and no part of the income of this Corporation shall be distributed to its Member, directors, or officers, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or any other corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IV Incorporator

The Incorporator of the Corporation is Joseph Tomberlin, 1528 Sixth Street, West Palm Beach, Florida 33401.

ARTICLE V Member

The initial Member of this Corporation shall be Joseph Tomberlin. Additional Members may be appointed from time to time by the initial Member or by the majority of members so appointed.

ARTICLE VI TERM OF EXISTENCE

The Corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation unless sooner dissolved by law.

ARTICLE VII STREET ADDRESS OF INITIAL REGISTERED OFFICE AND NAME OF INITIAL REGISTERED AGENT AT THAT OFFICE

The street address of the Corporation's initial registered office and the name of the initial registered agent is:

ARTICLE VIII Board of Directors

This Corporation shall have no less than three (3) Directors. The Directors of this Corporation shall be appointed by the Member(s), and may be removed by the Member(s) at any time.

ARTICLE IX Bylaws

The Bylaws of this Corporation shall be made, altered, amended or rescinded at any organizational, regular or special meeting of the Board of Directors of this Corporation by the affirmative vote of a majority of all then-sitting Directors.

ARTICLE X Indemnification

Every Member, Director and Officer of this Corporation shall be indemnified by this Corporation to the full extent permitted by law against all expenses and liabilities, including attorney's fees in trial and appellate proceedings, reasonably incurred by or imposed upon him or her in connection with any proceeding to which he or she may be a party, or in which he or she may become involved, by reason of his or her being or having been a Member, Director or Officer of this Corporation, or any settlement thereof, whether or not he or she is a Member, Director or Officer at the time such expenses are incurred unless the liability of the Member, Director or Officer in question is adjudged by decision of court to result from the gross negligence or willful misconduct of such Member, Officer or Director in the performance of his or her duties; provided, however, that in the event of a settlement, the indemnification herein shall apply only when the Board of Directors approves such settlement and reimbursement as being in the best interest of this Corporation. The foregoing right of indemnification shall be in addition to and shall not be exclusive of all other rights to which said Member(s) Directors or Officer(s) maybe entitled.

ARTICLE XI Dissolution

In the event of dissolution, any residual assets of this Corporation shall be distributed as directed by the Member(s) for one or more exempt purposes specified in Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Internal Revenue law of the United States, or to the federal, or a state, or a local government for exclusively public purposes.

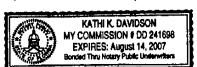
