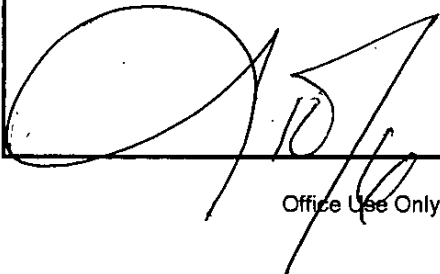

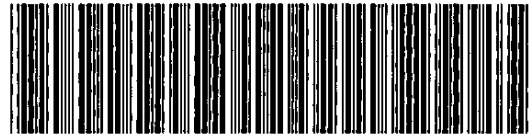

ARTICLES OF INCORPORATION OF
PATRONATO INCA CGIL- USA, INC.
A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be Patronato INCA CGIL-USA, Inc.

The principal address of the corporation at the time of incorporation is 944 Country Club Blvd., City of Cape Coral, County of Lee, Florida.

The mailing address of the corporation at the time of incorporation is 944 Country Club Blvd., Cape Coral, FL 33990.

ARTICLE II. PURPOSE

(a) The specific and primary purpose for which this corporation is organized is to provide free of charge assistance for educational purposes and service to members of the local Italian-American community.

(b) This corporation is formed and shall be operated exclusively for educational pleasure, recreation, and other nonprofit purposes. No part of any net earnings shall inure to the benefit of any member, trustee, or officer of the corporation except as provided by law.

ARTICLE III. QUALIFICATION AND ADMISSION OF MEMBERS

The authorized number, qualifications, and manner of admission of members of this corporation, the different classes of membership, if any, the property, voting, and other rights and privileges of members, the liability of members for dues and/or assessments and the method of collection thereof, and the termination and transfer of membership shall be as set forth in the bylaws of this corporation.

ARTICLE IV. REGISTERED OFFICE AND REGISTERED AGENT

The street address of the corporation's initial registered office is 2305 SE 18TH Avenue, City of Cape Coral, County of Lee, Florida 33990 and the name of the corporation's initial registered agent at such address is Cesarina Mckinney.

ARTICLE V. FIRST BOARD OF DIRECTORS

The following three persons shall serve the corporation as directors until the first annual meeting or other meeting called to elect directors:

ARTICLE VI. BASIS UNDER WHICH CORPORATION ORGANIZED

The corporation is a not for profit corporation as defined by the Not For Profit Corporation Act in Section 617.01401 of the Florida Statutes. As such, it is not organized for the pecuniary gain or profit of, and its net earning nor any part thereof is distributable to, its members, directors, officers, or other private persons except as specically permitted under the provision of the Florida Not For Profit Corporation Act.

ARTICLE VII. MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Directors. The power of this corporation shall be exercised, its properties controlled, and its affairs conducted by the board of three (3) directors. The number of directors provided for in these Articles of Incorporation may be changed by a bylaw adopted by the board of directors or members entitled to vote.

(b) Election of Directors. The method of electing directors shall be as set Forth in the bylaws.

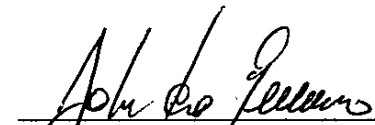

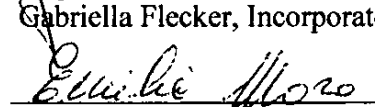
