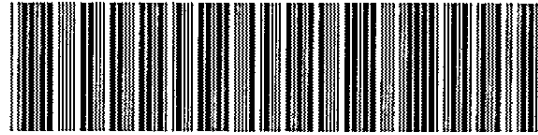

OF

ARTICLE I -- NAME

The name of the corporation shall be: **Village-to-Village Ministries, Inc.**, a Florida Not-for-profit corporation.

ARTICLE II-- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: **20120 SW 115 Avenue, Miami, Florida 33189.**

ARTICLE III -- PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

ARTICLE I -- MANNER OF ELECTION

The manner in which the directors are elected or appointed is as set forth in the By-Laws of the organization.

ARTICLE V -- INITIAL DIRECTORS AND/OR OFFICERS

ARTICLE VI -- DISTRIBUTION OF EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be

authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except in an insubstantial degree, engage in any activities or exercise any powers that not in furtherance of the purposes of this corporation.

ARTICLE VII- DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s) as said court shall determine, which are organized and operated exclusively for such purposes.

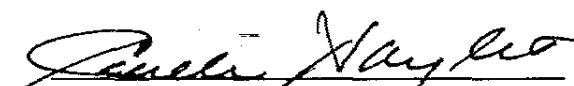
