The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I NAME

The name of the Corporation shall be Water is Life International, Inc.

ARTICLE II PRINCIPAL ADDRESS

The principal office of the Corporation is 738 Rugby Street Orlando, Florida 32804.

ARTICLE III PURPOSES AND GENERAL POWERS

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV ELECTION OF DIRECTORS

The Directors will be appointed by the current Board of Directors for a three year term. If a Director resigns, the Board shall appoint a replacement to fill the remainder of that Director's term.

ARTICLE V INITIAL BOARD OF DIRECTORS/OFFICERS

The names, address and titles of the Directors/Officers are listed on the attached Schedule A.

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be located at 738 Rugby Street Orlando, FL 32804 and the initial registered agent of the Corporation at that address shall be W.M. Sanderlin. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

ARTICLE VII INCORPORATOR

The name and street address of the person signing these Articles as Incorporator is:

ARTICLE VIII ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
