**ARTICLES OF INCORPORATION**

**ARTICLE I**  
**NAME**

The name of this corporation is Think Pink Breast Cancer Foundation, Inc. (hereinafter referred to as the "Foundation")

**ARTICLE II**  
**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation is 4116 Shelley Road North, West Palm Beach, Florida 33407

**ARTICLE III**  
**PURPOSE**

Think Pink (Breast Cancer) Foundation is a charity foundation. The mission of this foundation is to promote the physical, mental and spiritual well-being of women, girls and families (impacted by Breast Cancer) through charitable services that promote greater access to education, advocacy, support, and other activities as identified to respond to the current needs of the times. We are also committed to provide funding to breast cancer support and awareness organizations.

**ARTICLE IV**  
**MANNER OF ELECTION**

The board will be comprised of the founders of the organization. New members will be reviewed by the president and the chairman and voted on by existing members. To be accepted to the board as a new member candidates must receive a 2/3 majority vote.

Founding Board members have been appointed by the President/Founder of the organization. Each officer will serve a 2 year term. At the end of each term the officers will be given the option to serve an additional term (with the exception of the officer progression).

**OFFICERS PROGRESSION**

1. President to Chairman
2. Chairman to President

The board will be comprised of the founders of the organization. New candidates for board membership can be nominated by an existing board member or can personally request to participate on the board. Each candidate will be reviewed by the president and

the chairman and meeting the basic requirements: In good standings with the community and hold a genuine interest to helping Breast Cancer victims. If accepted, he/she will be voted on by the existing board members. To be accepted to the board as a new member candidates must receive a 2/3 majority vote.

## **ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS**

## ARTICLE VIII

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE IX

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."


## ARTICLE X

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
