ARTICLES OF INCORPORATION CITIZENS AGAINST BIGGER GOVERNMENT AND HIGHER TAXES, INCO A FLORIDA NOT FOR PROFTIT CORPORATION ALLAMASSEE, FLORIDA

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby state:

ARTICLE I - NAME

The name of the corporation is: Citizens Against Bigger Government and Higher Taxes, Inc.

ARTICLE II – PRINCIPAL OFFICE

The initial street address of the principal office of the corporation is: 1224 Greensward Drive, PMB 323, Tallahassee, FL 32312. The corporation may from time to time move its principal office to another location.

ARTICLE III - PURPOSE

The purpose of the corporation is to:

- A. Facilitate the discussion of public policy issues of importance to the residents of Volusia County, Florida;
- B. Inform residents of Volusia County, through the production of advertisements or direct mailings, of public policy issues of importance and of the views of public officials and others participating in public affairs on those issues;
- C. Implement such programs to make the public aware of issues of public importance;

ARTICLE X – DISTRIBUTION OF ASSETS

In the event of the dissolution or final liquidation of the corporation, all of the remaining assets and property of the corporation shall, after paying or making provision for the payment of all the liabilities and obligations of the corporation and for necessary expenses thereof, be distributed to such individuals as determined by the directors for the purposes set forth in Article III hereof. In no event shall any of such assets or property be distributed to any officer or director of the corporation or to any private individual.
