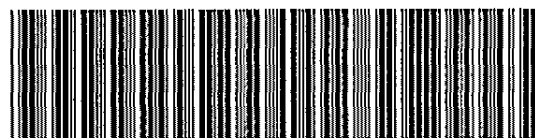

**Articles of Incorporation
Of
Eagle Wings Teaching Ministries Of Christ Fellowship Church, Inc.**

Preamble

Whereas God, is the giver of deliverance (Exodus 19:1, St. John 3:16-17, II Timothy 3:10-12) has in these last days founded His Church upon Christ Jesus, (Matthew 16:13-18, Ephesians 2:19-22, I Corinthians 3:11, built it through His people (I Corinthians 3:5-15, I Corinthians 12:12-31), gave it power and authority (Act 1:8, Acts 2:1-11, Matthew 16:19), and unified it with internal structure (I Corinthians 12:27-31) and the Holy Ghost as its guide (John 16:13-15), that we, as the body of Christ (Ephesians 1:22-23, Romans 12:5) might present His Full Gospel Teachings (Matthew 28:18-20, Mark 16:15-18, John 14:23-24, John 3:3-5, Acts 2:38-47, Colossians 1:28-29) and care for the down trodden and destitute (Matthew 7:12, Matthew 25:31-46). We now implement the vision of this Gospel Of Water and The Spirit, Evangelical Bible Teaching, Religious, Charitable and Educational Ministry to carry forth the true fellowship (I John 1:5-2:2) and teachings of Christ Jesus and the illumination of Christ teachings given by His Apostles (II Tim 3:10-15).

Therefore, we the original incorporators and board of directors each being competent, hereby form ourselves and successors into a not-for-profit corporation pursuant to the statues of the State of Florida.

Article I

The name of this Corporation shall be: Eagle Wings Teaching Ministries Of Christ Fellowship Church, Inc. and shall also be referred to as the "Ministry" within these articles of incorporation.

Article II

The principal place of business of the ministry and its mailing address shall be: 201 Oak Street, New Smyrna Beach, Florida 32168

Article III

This ministry shall be perpetual.

Article IV

Membership into this ministry shall be as govern by the by-laws of the Book of Fellowship of the Teaching Ministries of Christ Fellowship International and Eagle Wings Teaching Ministries Of Christ Fellowship Church, Inc..

Article V

A majority vote within this ministry shall be 50% plus 1

Article VI

A quorum of the membership within the corporation shall be no less than 1/3 of the voting members of the ministry at a duly call meeting by the Senior Pastor/President and/or Co-Pastor (Asst. Sr. Pastor) of the ministry to conduct its general or special business per the by-laws of the ministry.

Article VII

A quorum within the Board of Directors to vote on business of this ministry shall be no less than two thirds (2/3) of the members of the Board of Directors.

Article VIII

The Board of Directors of this corporation shall be no less than three (3) and no more than eleven (11).

The duties of the Board of Directors shall be the care of properties of this corporation and recommend policy for the corporation, under the guidelines of the by-laws of this corporation.

The Board of Directors shall have the power to appoint others to help it carrying out its duties from time to time.

The Board of Directors shall also have the responsibility to help in the process of selecting a Senior Pastor/President in the absent (resignation, dismissal or death) of a Senior Pastor/President to the membership of the ministry for approval. However if there is a Co-Pastor (Asst. Sr. Pastor) of the Ministry then the Co-Pastor (Asst Sr. Pastor) shall become the Senior Pastor/President in the event of resignation, dismissal or death of the Senior Pastor/President.

Article IX

The Senior Pastor/President of Eagle Wings Teaching Ministries of Christ Fellowship Church, Inc. shall have sole power to appoint and dismiss any member of the Board of Directors who fails to carry out his or her duties as given in the by-laws. This action may be under taken without a vote of approval of the Board of Directors or membership of the Ministry, however the Senior Pastor/President must report his/her action within (7) seven days to the membership of the Ministry and his/her action(s) maybe reverse by a majority vote of the membership in good standing of the corporation.

Article X

The election of board members, standing committee members, and group leaders shall be the first Friday in December. Those elected to their position in December shall begin their duties on January 1st.

Article XI

Article XII

The Senior Pastor/President (Co-Pastor as directed by the Sr. Pastor), shall have the right and duty to appoint non-standing committees and fill vacant position (s) until the general election meeting of the Ministry on the first Friday in December.

Article XIII

All persons in charge of any conference work-shop, special academy, auxiliary or ministry within this corporation must have the approval of the Senior Pastor/President and the ministry membership of this corporation before he or she may become a Conference Workshop Leader, Academy Leader, Auxiliary Leader or Ministry Leader.

If the Senior Pastor/President and ministry membership fail to agree on any leader/nominee then a new selection must be made following the guidelines of the Book of Fellowship of the Teaching Ministries of Christ Fellowship International.

Article XIV

The Senior Pastor/President and/or Co-Pastor (Asst. Sr. Pastor) of Eagle Wings Ministries Of Christ Fellowship Church, Inc. shall have the right to oversee, rebuke with all authority, reproof, correct, instruct or silent any disorderly member of the ministry as guided by Act 20:28, Titus 2:15, II Timothy 3:16-17, Titus 1:10-11, I Peter 2:15 and the Book of Fellowship of the Teaching Ministries of Christ Fellowship International.

Article XV

Any disagreement and action of correction within this ministry shall be handle as prescribe in the "New King James Bible and the "New International Version Bible", per St. Matthew 18:15-17 and Acts 15:6-29. In shall be right of any accused member or the majority of the membership to have any dispute within the ministry to have FINAL ARBITRATION by a council of Elders (Bishop and Elders) after the matter being first heard before the church under the guidelines of the Book of Fellowship of the Teaching Ministries of Christ Fellowship International.

Article XVI

While maintaining its inherent right to sovereignty in the conduct of its own affairs as directed by the Book of Fellowship of the Teaching Ministries of Christ Fellowship International. The Ministry shall however seek to maintain a cooperative fellowship with other Faith-Base organizations, churches, fellowships, ministries and community groups that are deemed mutually benevolent and beneficial to the vision of this ministry.

Article XVII

Upon retirement or disability of the Senior Pastor/President and/or Co-Pastor (Asst. Sr. Pastor) shall receive retirement annuity plus social security retirement benefits or no less than 55% of his/her annual salary for life and have the right to appoint his or her successor. If the Senior Pastor/President and/or Co-Pastor (Asst. Sr. Pastor) die in office then all of his/her retirement annuity plus social security retirement benefits or 55% of his/her annual salary for life shall be paid to his or her beneficiary.

Article XVIII

Upon the dissolution of winding up of this corporation, any assets remaining after payment of debts, of the corporation shall be disbursed to the Teaching Ministries of Christ Fellowship International.

Article XIX


The name of the first registered agent shall be as listed and thereafter all future registered agent shall be the Secretary of the Ministry.
