**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

**Article I**

The name of the corporation is: SUNSHINE STATE HEARTS 2 HEARTS, INC., and the initial principal address of the Corporation is: 2211 South Indian River Drive, Fort Pierce, FL 34950.

**Article II**
