ARTICLES OF INCORPORATION OF FENELON UNIVERSITY INC.

OB OCT / CO The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

I NAME OF CORPORATION:

VIII CORPORATE PURPOSES:

The purposes for which this corporation is formed are exclusively: Education, schools, religion, universities, research centers, and consist of the following:

- 1.) To establish schools, universities, seminars, distance learning, national and international. To raise the ethical and the educational levels of US citizens at home and abroad. To fight discrimination, crime, immorality, sicknesses, illiteracy, poverty. It is the purpose of the corporation thereby to relieve the poor, distress, underprivileged and indigent by enabling them to secure the basic human needs and to thus lessen the burden of the government, and promote social welfare.
- 2.) To raise the educational, ethical, and social levels of US citizens, including Members of the minority community, who are substantially unemployed, under employed, to foster and promote community wide interest and concern to the end that (a) educational and social opportunities may be expanded; (b) Poverty, crime, illiteracy may be lessen; and © racial tensions, prejudice, discrimination, and otherwise, may be eliminated.
- 3.) To aid, support, and assist by gifts, contributions, or otherwise, other corporation, community chests, funds and foundations organized and operated exclusively for charitable, educational or scientific purposes. No part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

- 4.) To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.
- 5.) All of the foregoing purposes shall be exercised exclusively for: religious, Charitable, and educational purposes in such a manner that the corporation will be qualified as an exempt organization under section 501 © (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

X 501 © (3) LIMITATIONS:

- A. CORPORATE PURPOSES: Notwithstanding any other provision of Theses articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from federal and state income tax under section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or by a corporation, contributions to which are deductible under section 170 © (2) of the Internal Revenue Code of 1986, or the corresponding provision of any future federal tax code.
- B. EXCLUSIVITY: The corporation is organized exclusively for Educational, religious, and charitable purposes.
- C. NO PRIVATE INUREMENT: The corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The corporation shall not distribute any gains, profits or dividends to the directors, officers, or members thereof (if any), or to any individual, except as reasonable compensation for services actually performed in carrying out the corporation's educational, religious, purposes. The property, assets, profits and net income of the corporation are irrevocably dedicated to educational and religious purposes no part of which shall inure to the benefit of any individual.
- D. LOBBYING AND POLITICAL CAMPAIGNS: No substantial part of The activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of (or in opposition to) any candidate for public office.
