ARTICLE OF INCORPORATION
FOR

The undersigned, acting as incorporator(s) of a Corporation pursuant to chapter 617 Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: TOUCH OF GLASS CONDOMINIUM ASSOCIATION, CORP

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of Business and the mailing address of this Corporation shall be:

ARTICLE III PURPOSE AND POWER(S)

The specific purpose(s) for which the corporation is organized is (are) : **NON-PROFIT ORGANIZATION**, To provide an entity pursuant to the Florida Condominium Act for the operation of Condominium TOUCH OF GLASS CONDOMINIUM ASSOCIATION, located in 627, 629, 631 633, 635, 637, 639 West 68th Street Hialeah FL 33014. The Association is organized and shall exist upon a non-stock basis as a Florida Corporation not for profit. No portion of any earning of the Association shall be distributed or inure to the private benefit of any member, Director or Officer. For the accomplishment of its purpose, the Association shall have all of the common law and statutory powers and duties of a corporation not for profit except as specifically limited or modified by these Articles, the Declaration of Condominium or Chapter 718, Florida Statutes, as it may hereafter be amended, including without limitation the following powers and duties:

- A- To levy and collect assessments against members of the Association to defray the costs, expenses and losses of the Condominium and to use the proceeds of assessments in the exercise of its powers and duties.
- B- To protect, maintain, repairs, replace and operate the condominium property, including property tax and permits required from City and Dade County.

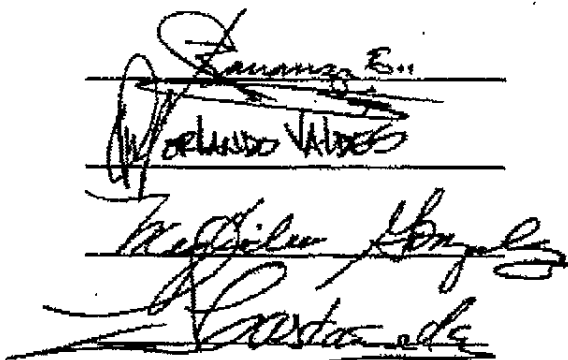
