The undersigned not-for-profit Corporation hereby certifies the following:

- 1. The name of the Corporation is Lea's Prayers and Postage, Inc.
- 2. The Corporation was formed on October 12, 2006, upon the filing of the Articles of Incorporation in the Office of the Secretary of State, where said Articles were assigned document number N06000010738.
- 3. In accordance with Florida Statute 617.1006, all of the Members and all of the Directors of the Corporation hereby declare it to be their intention that Article 2 of the Articles of Incorporation of Lea's Prayers and Postage, Inc. be amended as follows:

ARTICLE 2: CORPORATE PURPOSE

Within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, the purpose for which the Corporation is organized is to fund postage for mailings to our military men and women.
