

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

**Article 1**

The name of this corporation is Contend for the Faith, Inc

**Article 2**

The principle place of business is 37430 Moore Drive, Dade City, Florida 33525.

The mailing address is P.O. Box 1142, Dade City, Florida 33526-1142

**Article 3**

The purposes for which this corporation is organized are to establish a religious organization to produce, publish and promote educational materials of a theological nature such as post-secondary textbooks, curriculum and testing materials; bible study guides for individual and small group or Sunday school use as well as teaching syllabi and other educational material intended for the purpose of increasing biblical knowledge and spiritual growth.

**Article 4**

The manner in which the directors are elected or appointed is as stated in the bylaws of this corporation.

**Article 5**

The number of initial directors of this corporation shall be three and the names and addresses of the initial directors are as follows:

The period of duration of this corporation is perpetual.

## **Article 9**

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows: The membership provisions of this corporation shall be stated in the bylaws of the corporation.

## **Article 10**

The property of this corporation is irrevocably dedicated to religious or educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its member, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
