ARTICLE I: NAME

ARTICLE III: PURPOSE

Anglican Beaches Church is organized exclusively for religious purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth here. No substantial part of the activities of the corporation attempts to influence legislation, participate or intervene (including publishing or distributing statements) in any political campaign on behalf of or in opposition to any candidate for public office. Additionally, the corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction within Duval county to such organizations organized for such purposes.

ARTICLE IV: MANNER OF ELECTION

Vestry (directors) shall be elected annually by a majority of adult pledging members commencing one year after the first election. The number of vestry shall equal 10 % of the number of pledging units, in increments of three, with a minimum of three and a

maximum of twelve. Beginning with the second election, 1/3 of the vestry will be elected for one year, 1/3 for two years, and 1/3 for three years. Decisions of the vestry shall be by majority vote of serving vestry members, excepting decisions concerning capital expenditures, removal of a vestry member, and selection and hiring of clergy, each of which shall require the support of 2/3 of serving vestry members. The vestry shall elect its officers.
