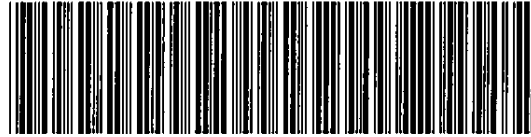

ARTICLE I

The name of the corporation shall be: **ONE ACCORD MINISTRIES IN JESUS NAME, INC .**

ARTICLE II

ARTICLE III

The purposes for which this corporation is organized are exclusively charitable, religious, educational and scientific. Including to establish a bible based Christ centered Church and related ministries which will participate in the great commission by winning souls to Christ, by preaching the gospel, evangelism, discipleship, corporate worship and fellowship, while ministering to and meeting the spiritual, emotional and physical needs of people. Also, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code. Publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, its assets remaining after payment, or provisions for payment of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government or to the state or local government for a public purpose.
