Pursuant to the provisions of

- (1) Section 607.1006, Florida Statutes; and
- (2) Section 3 of Article XI of the Articles of Incorporation of Weschester Homeowner's Association, Inc. (the "Articles" herein); and
- (3) Provision 3(v) of Section G of Article XI of the Declaration of Covenants, Conditions, Restrictions, and Easements for Weschester, Phases I, II, III and IV,

Weschester Homeowner's Association, Inc., a Florida not for profit corporation (the "Company" herein), adopts the following amendment to its Articles of Incorporation:

Section 2 (C) of Article VI of the Articles is amended to read as follows:

- "(C) <u>Conversion of Class B Membership</u>. Declarant's Class B membership shall continue in effect during the period from the date of the Declaration until the earlier of the following events, following which the turnover of the Association to the Owners, other than the Declarant ("Turnover") shall be conducted:
- (1) Ninety (90) days after the date on which ninety percent (90%) of all Lots in Phases I, II, III, and IV of Weschester have been conveyed to Owners other than the Declarant; or
- (2) At such earlier time as the Declarant, in its sole discretion, may elect to turnover the Association to the Owners, which Turnover shall be evidenced by a written notice of Turnover signed by the Declarant and delivered by mail or by hand to the President or the Secretary of the Weschester Homeowner's Association, Inc."

This Amendment was adopted by the Board of Directors of the Company on April 18, 2011 (the "Date of Adoption"), and was adopted by all of the members entitled to vote on that date.

The Effective Date of this Amendment is the Date of Adoption.
