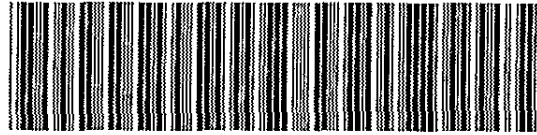



ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Corporation shall be:

V.R.H. Ministries, Incorporated

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be:

ARTICLE IV PURPOSE

The purpose for which the corporation is organized exclusively for charitable, religious, educational and scientific purposes, within the meaning of section 501 (c)(3), including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code;

VRH Ministries, Inc. will provide non medical detoxification from drugs and alcohol, provide shelter and to help redevelop the entire person, including physical, spiritual and emotional.

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Directors are elected by a majority vote on an annual basis.

ARTICLE VI DISSOLUTION OF ORGANIZATION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located; exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


