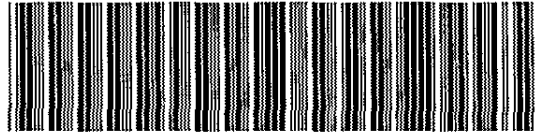

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby form a corporation not for profit under the law of the State of Florida.

ARTICLE I – NAME

The name of the corporation is **GREENSBORO FOOTBALL SOCCER INC.**

ARTICLE II – PRINCIPAL OFFICE

PURPOSE

The general character or nature of the business to be transacted by this corporation is as follows:

a) To acquire by purchase, lease or otherwise, lands and interest in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held or occupied by the corporation, buildings or other structures, now or hereafter erected on any lands so owned, held or occupied, and to encumber or dispose of any lands, or interest in lands, and any buildings or other structures, at any time owned or held by the corporation. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds improved or unimproved, or any right or interest therein. All of the above activities are to be non-profit in nature.

b) To acquire, by purchase, lease, manufacture or otherwise, any personal property deemed necessary or useful in the equipment furnishings, improvement, development or management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade, lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation. All of these are to be non-profit in nature.

(c) To enter into, make perform and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any firm, association or corporation; and to transact any further and other business necessarily connected with the purposes of this corporation, or calculated to facilitate the same.

f) To carry on any or all of its operations and business, and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amounts; and to have, use exercise and enjoy all of the general powers of like corporations.

g) To transact any and all lawful business for which non-profit corporations may be incorporated under the Florida Not for Profit Corporations Act

h) To function as a Soccer League engaged in the sport of Soccer in and around Greensboro Florida. The teams will be divided, and each team will have their own players. And they will compete against one another. The teams will be under the supervision and control of the directors of this corporation, and they are to conform to the rules and by-laws established by this corporation.

ARTICLE VI - DIRECTORS

The corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time by the By-Laws but shall never be less than three. *Appointed By David Garcia*

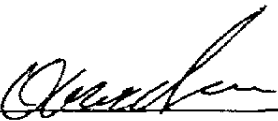

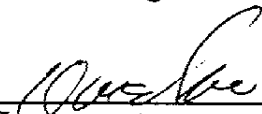
